Philosophy Statement

Our program and facilities adhere to the highest quality standards for education and environment as governed by the regulations and principles of all applicable local, state and federal agencies.

We feel that every child is special and unique. With a low student/teacher ratio, our program provides "hands-on", center-based activities, along with direct instruction which gives each child the opportunity to grow and succeed.

Mission Statement

The mission of Academy Adventures Midtown is to create an environment where students are able to take charge of the learning by recognizing and building on their strengths.

Accidents

If a serious injury occurs on the school grounds, parents/guardians will be notified and asked to pick up their child from school for personal observation or examination by the family physician. Parents/Guardians will be promptly notified of other injuries. In the event that the parents/guardians cannot be reached, the student will be released to a person named on the emergency card. It is critical that emergency cards be completed and up-to-date.

Admission

Admission is not based on ethnicity, national origin, gender, income level, disabling condition, proficiency in the English language or athletic ability. Academy Adventures Midtown offers a full day Kindergarten program and grades $1^{st} - 5^{th}$. Pursuant to A.R.S. §15-828, a certified copy of your child's Birth Certificate other reliable proof of identity and age (including Baptismal Certificate, application for Social Security Number or original copy of school registration records and an affidavit explaining the inability to provide a copy of Birth Certificate) OR a letter from the authorized representative of an agency having custody of the pupil pursuant to Title 8, Chapter 3 certifying that the pupil has been placed in custody of the agency as prescribed by law; immunization records and proof of Arizona Residency be provided for admission.

Assessments, Portfolios & Performance

The faculty and staff use several methods to assess and measure the progress of students. Standardized tests, portfolios, student performance and/or other assessments are used to judge students' knowledge of basic skills and their use of that knowledge. Student performance is assessed as students demonstrate their mastery of knowledge and skills in each subject area.

Attendance & Absences

It is very important to your child's education that he/she attend school on a regular basis. Missed days of school can deter the education process. If your child is absent, please contact the school office as early as possible each day the student is absent. Upon returning to school after an absence, a child must bring a note signed by his/her parent/guardian stating the date of and the reason for the absence. This note must be presented to the office. Notice in advance of absences is appreciated. Parents/Guardians may leave a telephone message followed by a note. Please note that there is a potential of retention if a child misses ten percent (10%) of the school year (approximately 18 days). We really want your child in school all day, every day so that we can do our job to teach them! Also note that tardies and early pick-up add to absences. Four (4) tardies and/or early releases will count as 1 absence.

Attendance Policy

Student attendance is crucial to your child's academic success. Academy Adventures Midtown has a strict attendance policy. Per *Arizona Revised Statute §15-803*:

A. It is unlawful for any child who is between six and sixteen years of age to fail to attend school during the hours school is in session, unless either:

1. The child is excused pursuant to section Arizona Revised Statute §15-802, subsection D or section A.R.S §15-901, subsection A, paragraph 5, subdivision (c).

2. The child is accompanied by a parent or a person authorized by a parent.

3. The child is provided with instruction in a homeschool.

B. A child who is habitually truant or who has excessive absences may be adjudicated an incorrigible child as defined in section A.R.S. §8-201. Absences may be considered excessive when the number of absent days exceeds ten percent of the number of required attendance days prescribed in section A.R.S. §15-802, subsection B, paragraph 1.

C. For the purposes of this section:

1. "Habitually truant" means a truant child who is truant for at least five school days within a school year.

2. "Truant" means an unexcused absence for at least one class period during the day.

3. "Truant child" means a child who is between six and sixteen years of age and who is not in attendance at a public or private school during the hours that school is in session, unless excused as provided by this section.

Per Arizona Revised Statute §15-806

subsection A - absences due to religious purposes, including participation in religious exercises or religious instruction. A pupil will be excused based on the following stipulations:

1. The person who has custody of the pupil has given written consent.

2. Any religious instruction or exercise takes place at a suitable place away from school property designated by the church or religious denomination or group.

subsection B - the excuse of pupils from school attendance for authorized school closure for the following reasons:

1. Widespread illness for any period of three consecutive days or more.

2. Adverse weather conditions for any period of three consecutive days or more.

3. Concerted refusal by students to attend classes for any period of three consecutive days or more.

4. Threats of violence against school property, school personnel or pupils for any period of one day or more.

5. Situations affecting the safety of persons or property resulting from fire, flooding or floodwater, an earthquake, a hazardous material event or another cause if approved by the

department of education.

Per *Arizona Revised Statute* §15-807 absences (as well as tardies and early releases) are tracked daily, recorded and parents/guardians of children who are not at school are contacted within 2 hours of school starting.

Excused absences are identified by the Arizona Department of Education (ADE). Per **A.R.S.** §15-901(A)(1) The Arizona Department of Education defines an excused absence as an absence due to illness, doctor appointment, mental or behavioral health, homelessness, bereavement, family emergencies, time necessary to process for the armed forces, and out-of-school suspensions. Excused absences due to out-of-school suspensions must not exceed 10% of the instructional days scheduled for the school year. The Department of Education delegates the decision whether an absence due to family vacation is an excused absence to individual school districts and charter districts.

Parents/Guardians are expected to call the school to report absences or late arrivals. If you have to leave a message, please include the date, time, name of your child and reason they will be out or late. If your child is out and we are unable to reach you and you have not contacted the school, your child will receive an unexcused absence. If your child has ten (10) consecutive unexcused absences this will result in your child being withdrawn from school.

Students who arrive after school begins or leaves before school is out, may be marked absent for half day or full day depending on the time of arrival. Absences are based on minute requirements set forth by the state for each grade level.

Parents/Guardians of students with excessive absences (10% or more) will be required to meet with the child's teacher to create a plan for improved attendance. For the purposes of this policy, four (4) tardies and/or early releases will be considered one (1) absence.

Chronic Illness

Purpose: The purpose of this policy is to ensure that students with chronic illnesses and/or are hospitalized due to chronic illness receive appropriate accommodations and support to continue their education while at home or in the hospital and seamlessly reintegrate into the school environment upon their return.

Scope: This policy applies to all students in grades K-5 enrolled in Academy Adventures Midtown, located in Tucson, AZ.

Definitions:

1. **Chronic Illness:** A medical condition that is persistent, long-lasting and requires ongoing medical management and care.

2. **Hospitalization:** Admission of a student to a medical facility for an extended period due to a chronic illness or medical treatment.

Policy:

1. Communication:

• Parents/Guardians of students with chronic illnesses are responsible for informing the school administration of their child's medical condition and the possibility of hospitalization. This information should be provided as soon as possible to allow for appropriate planning.

2. Educational Accommodations during Hospitalization:

• The school will work in collaboration with the student's medical team to provide educational materials, assignments, and assessments that can be completed while the student is in the hospital.

• A designated teacher or educational liaison will facilitate communication between the school, the student, and the medical team to ensure a consistent and supportive learning experience.

• Whenever feasible, the school will provide electronic resources, video conferences, or other digital platforms to facilitate remote learning for the hospitalized student.

• Accommodations will be tailored to the individual needs of the student, taking into consideration their medical condition and abilities.

3. Educational Accommodations after Hospitalization (Homebound):

• The school will work with parents, guardians, and medical professionals to create a plan that outlines specific accommodations and support for the student's remote learning experience.

• Accommodations may include flexible attendance, extended deadlines, access to assistive technology and alternative assessment methods.

• Teachers will provide instructional materials, assignments and activities that are accessible and adaptable to the student's individual needs and abilities.

• Whenever possible, lessons will be recorded or provided in written format to accommodate students who may need to review content at a later time due to health-related factors.

4. Reintegration Process:

• Upon the student's return from the hospital or from being homebound, the school will work with the student, parents/guardians, and medical team to develop a reintegration plan that addresses the student's medical needs and any necessary academic adjustments.

• Teachers will provide additional support and flexibility to help the student catch up on missed work, adjust to the school routine, and address any physical or emotional challenges resulting from their hospitalization.

5. Confidentiality:

• All medical information shared by the student's family will be treated as confidential and will only be shared with relevant school staff who need to be aware of the student's condition and needs.

6. Supportive Environment:

• The school community will be educated about chronic illnesses and hospitalization to promote understanding, empathy, and inclusivity.

• Peer support and involvement will be encouraged to help the hospitalized or homebound student feel connected and supported by their classmates.

7. Emergency Procedures:

- In case of a medical emergency related to a chronic illness, the school will follow its established emergency procedures to ensure the safety and well-being of the student.
- Parents/guardians will be informed immediately in the event of a medical emergency.

8. Review and Modification:

• This policy will be periodically reviewed and updated as necessary to ensure its effectiveness and alignment with the needs of students with chronic illnesses.

9. Compliance:

• All school staff, parents/guardians, and students are expected to comply with this policy to ensure the successful implementation of accommodations for hospitalized students with chronic illnesses.

By implementing this chronic illness policy, Academy Adventures Midtown aims to provide a supportive and inclusive environment that ensures the continuity of education for students who are hospitalized due to chronic illnesses.

Birthdays

You are welcome to bring in birthday treats on your child's birthday as long as you consult with your child's classroom teacher in advance. Treats must be pre-packaged, store bought and/or from a bakery. Generally these celebrations will be done at the end of the school day before dismissal.

Extraordinary Heath Events

This policy may change based on state and local authority and/or policies.

Cell Phone

At Academy Adventures Midtown, face-to-face communication is highly valued. Academy Adventures Midtown implements a **No Cell Phone Policy at the school!** <u>All</u> <u>cell phone calls/texts should take place before entering or after leaving the school</u> <u>building to allow maximum opportunity for communication with staff</u>.

Students are not permitted to have cell phones and/or electronic devices on their person. Any cell phones or electronic devices must be checked in with a staff member. Cell phones and electronic devices will be returned as the child leaves the campus. If the child brought the device to school and it was taken away for being used without permission during the day, a parent/guardian will be required to come pick up the item.

Change of Address, Emergency Information, Withdrawal from School

Please notify the office of any changes in address, telephone numbers or emergency contacts. Academy Adventures Midtown must have an accurate, working telephone number on file where the parents/guardians can be reached in the event of an emergency. Please notify the school office in advance if your child will be withdrawn from school.

Confidentiality

Federal and state laws protect the interests of families and individual members of those families. These laws provide strict adherence to procedures which protect privacy rights. Failure to comply is considered an invasion of privacy and subject to penalties by law. The strict observance of privacy rights is a professional responsibility of all staff members and any volunteer serving the school. For questions regarding confidentiality, please discuss your concerns with the appropriate administrator.

Disciplinary Measures

A primary goal of Academy Adventures Midtown is to provide a safe and constructive learning environment for each student. A variety of disciplinary measures may be used to maintain that environment. Disciplinary proceedings are designed to provide the student more appropriate choices for the future. Staff members and the administration may use a variety of measures before formal disciplinary action is taken. All disciplinary measures are applied on an individual, student-by-student basis. *The application of any disciplinary measure is not sequential, but based upon the most appropriate consequence in a given situation.*

The following disciplinary measures may be applied:

- Redirection
- Time Away from Peers
- Parent/Guardian Contact
- Parent/Guardian and/or Student Conference
- Behavior Modification Plan

• Suspensions

The administration may suspend a student from school up to three (3) consecutive days due to the violation of selected school rules, policies and procedures. A student may be suspended for up to ten (10) days by school administration if disciplinary measures have been either exhausted or deemed inappropriate in a given situation. Conferences to determine this action shall be held with parents/guardians, the student and other involved staff members. Home learning and class assignments will be made available during the suspension. During any suspension, the student may not participate in any school activities; the student must remain off campus.

Drop Off & Pick Up

Students are to be dropped off and on the playground no later than 8:15 AM to be considered on time for school. Please wait for your student to be inside the building and acknowledged by a staff member before departing. Students are to be picked up promptly at 3:00 PM or before 5:00 PM if enrolled in the extended day learning program.

Drop off time is no earlier than 7:30 AM. Parents/Guardians will be expected to stay with their child outside if they arrive prior to 7:30 AM. For the safety of all students, they may not be dropped off and left alone prior to 7:30 AM.

On Early Dismissal Days all students will be dismissed at 11:30 AM. There will be NO after school program available on early dismissal days. All children must be picked up at 11:30 AM. If picked up before 11:30 AM, students must be signed out by a Parent/Guardian.

A child is not permitted to leave school or the school grounds before regular dismissal without prior written consent from the parent/guardian. Notes for early dismissal of students for the purpose of doctor appointments, dental appointments, etc. are requested. Please try to schedule all doctor, dentist and other appointments for early release days, school closure days or after school. **PARENTS OR AUTHORIZED ADULT OVER THE AGE OF 18 MUST CHECK-OUT THE CHILD THROUGH THE OFFICE IN ALL CASES OF DEPARTURE PRIOR TO DISMISSAL.**

Emergencies

In the event of an emergency, every attempt will be made to contact parents/guardians or emergency contacts if a student requires immediate medical attention. The emergency card on file in the school office lists emergency contacts. School staff will follow the parent/guardian's direction on the emergency card as closely as possible. *PLEASE FILL OUT THE EMERGENCY CARD COMPLETELY. IF THERE IS AN EMERGENCY IT IS IMPORTANT THAT THE SCHOOL HAS A NUMBER TO REACH YOU. IF THERE IS A CHANGE, NOTIFY THE SCHOOL IN WRITING (WITH DATE AND SIGNATURE) IMMEDIATELY SO THAT WE CAN UPDATE THE EMERGENCY <i>CARD.*

Family Participation & Involvement

Academy Adventures Midtown hosts a variety of special events throughout the school year. We encourage students and their families to actively participate in these events.

We have a schoolwide communication platform, Class Dojo. All communications will be done through Class Dojo, including but not limited to: reminders, event information, school closures, emergencies, flyers, change in policies, online newsletter link, etc. Parents/Guardians can also contact Administration and Teachers directly through Class Dojo. Class Dojo has the ability to translate into 35 different languages! The app for Class Dojo is free. We strongly recommend that parents/guardians download the free app and **enable notifications** so that you are aware of what is happening at the school.

Academy Adventure Midtown encourages an "open door" policy, which welcomes families to visit at any time. Visitors must sign in and obtain a "Visitor" sticker.

VISITORS, OBSERVERS, TOURS POLICY

Ed Ahead, Inc/Academy Adventures Midtown has an open-door policy. Adults, including parents of enrolled pupils and parents who wish to enroll their child(ren) at Academy Adventures Midtown, may visit, tour, and/or observe campus and/or classroom(s) during business hours without the need to schedule an appointment. The only exception to this policy is during formal, all-school testing times such as standardized testing. Those who wish to visit, tour, and/or observe the campus and/or classroom(s) must abide by the following practices:

1) Sign-In / Sign-Out Procedures - All adults on campus MUST sign in and out 2)

Visitor Stickers - All adults on campus must wear Visitor Sticker available at sign in

3) Dress Standards - Academy Adventures Midtown supports families and students with a comfortable environment for everyone who visits our campuses. Staff and families are role models for every new generation. We encourage visitors on our campuses to wear appropriate clothing. Clothing should cover midriffs, buttocks, and undergarments. Please avoid any clothing that is excessively short in length and too open around the neckline, back, or armholes. Academy Adventures Midtown will not deny attendance based on inappropriate dress.

4) Cell Phone - Please *turn off* your cell phone or switch the phone to vibrate while on campus.

5) Entering Classrooms - Please remember academic time is precious; therefore, enter the room quietly.

6) Observing - If the purpose of the visit is to observe, please be seated in the back of the room to begin your observation.

7) Student's Family Members - Many children are excited to have family members in the room and may disrupt the learning of others. Therefore, we ask that a child be acknowledged with a smile and unspoken greeting **only** and then redirect the child's attention to the teacher.

8) Teacher's Responsibility - A teacher is responsible for the school/class environment. If a teacher deems an adult/visitor is distracting to a student or students, he/she may ask the individual to leave.

9) Young Children (Baby, Toddler, Preschooler) - Please do not bring young children into the classroom.

10) Confidentiality - Anything an adult/visitor may hear or see may be considered confidential. We ask that these things are not discussed with others. Should there be an issue of concern, please bring the matter directly to the school administration. Things that are considered confidential include but are not limited to:

- a) Student behavior or progress
- b) Personnel information
- c) Student records/grades
- d) Inter-office memos
- e) Names and phone numbers (unless specifically authorized for release).

11) Campus Access / Restrictions

- a) Restrooms The adult/visitor restroom is located next door to the kitchen
- b) Students are not allowed wander around the building

c) Adults may eat lunch with their student during the designated lunch time at a designated lunch table.

12) Physical Displays of Affection with Children - It is best to avoid initiating physical contact with the students and limiting physical contact when initiated by a student.

Keep in mind some children do not like to be touched at all. (For example, an action as simple as a gentle hand on the back guiding the student could be an unwanted touch.) Staff may be able to communicate those children's needs or the child may back away after your touch. Please respect the child's wish to not be touched.

Physical or verbal contact with a child that makes the student feel uncomfortable communicated either by the student's words, actions or lack of response may be considered inappropriate.

13) Accidents / Injuries - An accident form must be completed when there is an accident or injury on campus. Forms are available from your child's teacher.

Family Conduct

Academy Adventures Midtown has a tradition of treating all members of the learning community with consideration and respect. Academy Adventures Midtown believes that all students, family members and staff have the right to a safe learning environment.

Family members do not have the right to swear, threaten, aggressively confront or touch any child, staff or other individuals on school property. *In addition, please be aware of your language, tone of voice and actions while in the school building, at school events or on school grounds.*

Fire Drills

Fire evacuation drills are held every month. Procedures are taught and practiced in preparation for fire or other emergencies.

Fundraisers

We appreciate all of your help with our various fundraising efforts. Your support helps the school support field trips and purchase additional equipment for the school.

Homeless Policy

The Arizona Homeless Education Program is dedicated to ensuring that all children and youth experiencing homelessness have access to the public education to which they are entitled under the federal McKinney-Vento Education of Homeless Children and Youth Assistance Act.

It is the policy of Academy Adventures Midtown to view children as individuals. Therefore, this policy will not refer to children as homeless; it will instead use the term children and youth in transition. Under federal law, children and youth in transition must have access to appropriate public education, including pre-school, and be given full opportunity to meet state and local academic achievement standards. They must be included in state and district wide assessments and accountability systems. Academy Adventures Midtown will ensure that children and youth in transition are free from discrimination, segregation and harassment.

Information regarding this policy will be distributed to all parents upon enrollment and once during the school year. Information will also be provided to a parent who seeks to withdraw their child from school. Posters will also be distributed twice a year in the surrounding neighborhood.

Our complete Homeless Policy can be found on our website.

Immunizations

State law makes it mandatory for parents/guardians to present evidence that their child has been protected against polio, diphtheria, pertussis, tetanus, mumps, measles and rubella. Immunization for Hepatitis B and second mumps, measles and rubella (MMR) is required. If your child has not been immunized, a medical, religious or personal exempt form must be on file.

Lice

A common problem on any school campus is head lice. Our primary concern is that head lice are easily transmitted from one student to another. Unless an infected student has all nits (egg sacks) removed, the lice will return. For these reasons, Academy Adventures Midtown recommends that students do not share hats, jackets, etc. Also, it is our policy that a student sent home for head lice must be completely nit-free before returning to school and must be checked in at the office before returning to class. Routine checks for head lice are performed by school staff.

Lost & Found

Each year we give away boxes of sweaters, clothes, lunch boxes and other miscellaneous items to a charitable institution. Please be sure to put your child's name on everything they bring to school so the item can be identified and returned to them.

Lunch & Breakfast

Academy Adventures Midtown participates in the National School Lunch Program (NSLP) and also serves breakfast. These meals are offered at no charge. Students may also bring lunch to school (we do not have the ability to heat lunches brought from home or the ability to refrigerate lunches or drinks). Please clearly mark your child's lunch with their first and last name. Lunch brought from home must follow the NSLP guidelines, which includes, but is not limited to: no sweets, no potato chips, no sodas, juices that are not 100% juice, etc.

If your child is allergic to specific foods and/or has a medical condition that limits certain foods, the USDA and NSLP require the school to have documentation from your child's physician to make those accommodations. The form is available through the school office.

Breakfast is served from 7:30 AM-7:55 AM. Students who arrive after 7:55 AM may not receive the full breakfast.

Medication

Parents/Guardians are required by state law to inform the school of medications that are to be taken by their child during school hours. Current dosage and the name of the supervising physician are needed. The school must receive written permission to administer medication. *The school office has the required forms*. Medications must be in the <u>original</u> pharmaceutical container. Medication is to be kept with administration. Medication is administered only at the times and dosage indicated on the pharmaceutical container. For the protection of your child and others, students who are ill should stay home. If a student becomes ill during the school day, a parent/guardian will be notified and asked to take the child home. *Students are not permitted to have cough drops and/or any other over-the-counter medication on their person*.

Pet Policies

The decision to have pets in our classrooms is made with great care. Pets of any kind require good care and their enclosures require cleaning. Some pets bite and scratch and may be frightened by children. A new child in the classroom may have allergies that require the pet to be removed from the facility. All of these issues require consideration before a decision is reached to allow a pet in our facility.

Pet Guidelines

Animals are chosen carefully for temperament and safety. We do not keep ferrets, turtles, iguanas, lizards or other reptiles, birds of the parrot family or any wild or dangerous animals. No pets from outside/home are allowed at Academy Adventures Midtown.

- No live animals are allowed in food preparation areas.
- Pet enclosures are not placed near areas where children eat or food is served.
- Children and adults wash their hands after handling or feeding animals.
- Children do not clean cages.
- All animals are properly cared for and provided clean water, appropriate food and clean cages.
- Food preparation/service facilities and supplies are not used to clean animal cages and aquariums.
- Animal food is stored separately from human food. Animal food is kept tightly closed to prevent insect infestation.
- We plan for the care of pets during holidays, weekends and vacations.

School Hours

School begins promptly at 8:15 AM and ends at 3:00 PM. Please refer to the schedule of hours for attendance. Students who arrive late must be signed in by a parent/guardian before going to class. Parents/Guardians must sign in each child when their arrival is after 8:15 AM. On-time arrival at school along with prompt pick-up after school will contribute to creating a true measure of safety for each child and help develop a strong sense of responsibility for their own education.

Sharing

Academy Adventures Midtown prohibits students from bringing toys, electronic devices or personal items to school unless they have specific permission from the teacher and a note from the parent which states that the parent understands that the school is not responsible for the item. Please be aware that Academy Adventures Midtown is not responsible for lost, stolen or damaged items.

Smoke-Free/Drug-Free Campus

Academy Adventures Midtown is a smoke-free/drug-free campus. No smoking (cigarettes, cigars, e-cigs, etc) or drug use is permitted at any time on our campus, including the parking lot, at any school function or during school activities, by any student or adult.

Snack

Each classroom has snack time during the morning. Academy Adventures Midtown has partnered with Cakes for Causes, a non-profit organization, who supplies some healthy treats to the school from time to time. In addition, there will be times that students have the opportunity to make healthy snacks. Students are permitted to bring in an individual healthy snack from home or families can donate snacks to the school to share. Academy Adventures Midtown is concerned that the food that families provide to students be healthy and nutritious in order to support the growth and development of the children. Students can drink water at any time during the school day. We know that eating vegetables and fruit and drinking water provides a great recipe for learning because it can improve energy levels, alertness and concentration.

ACCEPTABLE FOOD

- Fruit
- Vegetables
- Crackers, Wheat Thins, Saltines, Triscuits, etc.
- Cheez-Its
- Goldfish

UNACCEPTABLE FOOD

- Cookies
- Candy
- Fruit Roll-Ups
- Sugar Cereal
- Any type of Chips (potato, Takis, Cheetos, tortilla, etc)
- Any drink that is not water or 100% juice

Students will not be allowed to eat unacceptable foods during snack time or at breakfast or lunch.

Staff

The staff at Academy Adventures Midtown participates in professional development to increase their abilities to teach, model and interact with students and their families. Staff qualifications and backgrounds are available in the front lobby.

Sick Policy: Is Your Child Well Enough To Be In School Today?

Needs to Stay Home:

- Fever over 100 degrees (underarm)
- Sores that are open and appear infected and are not easily covered
- Vomiting within 48 hours
- Diarrhea within 48 hours
- Earache
- Red eyes with discharge
- Lice or nits are present
- Not well enough to participate in activities
- Has been to the hospital or emergency room within the last 48 hours
- Runny nose

- Cough
- Rash
- Been to the doctor with release from the doctor's office
- Is not acting like usual
- Family member that is ill

Have a Great Day (Return to School)

- Feeling well today
- Has been fever free for the last <u>48 hours</u>, without the aid of fever reducing medication
- Is free from all symptoms, without medication, for <u>48 hours</u>
- On antibiotics (if prescribed) for at least **<u>48 hours</u>** before returning to school

<u>Please note that the 48 hour requirement to return to school with no symptoms or</u> <u>fever (and without aid of medication) will be strictly adhered to.</u>

If a child shows any signs or symptoms of being sick, they will be sent home whether or not they have a fever and be required to stay home a minimum of 48 hours. They may return to school once they are free from symptoms and on no medications to mask symptoms for at least 48 hours.

Tardy

School begins at 8:15 AM. If your child arrives after 8:15 AM, they are considered tardy and need to be signed in by the parent/guardian. Please make every effort to get your child to school on time.

Uniforms

Students attending Academy Adventures Midtown are required to wear school uniforms. The regulation uniform is solid colored or striped long or short sleeved polo style, three button knit shirt or a button down blouse with a collar and navy blue, black or khaki pants, shorts, skirts, skorts or jumpers. Denim of any color is not permitted. Families are responsible for providing clothing appropriate for the weather. Shoes and socks that allow students to be active and participate in outdoor activities are recommended. Sandals and flip-flops or "no heel" footwear are not permitted. *Please see a copy of the Dress Code in your Parent Information Packet for more specific information.*

Weapons Prohibitions

No student shall carry or possess a weapon or simulated weapon on school premises or at school functions without authorization by a school administrator. No student shall display, use or threaten to use a weapon or simulated weapon to disrupt any activity of the school whether or not such use or threat of use occurs on or in close proximity to school premises.

Any staff member who observes a student in possession of a weapon or simulated weapon on school premises shall immediately report the matter to the school

administration. A school administrator who observes or receives a report of a student possessing a weapon on school premises shall immediately take appropriate safety and disciplinary actions in accordance with school policies and shall immediately report a violation of this policy to a peace officer if the weapon is considered a deadly weapon or the student is a minor in possession of a firearm.

A student that violates this policy by carrying or possessing a firearm or using or threatening to use a weapon or simulated weapon shall be in jeopardy of one of the following:

- 1. Being placed in a homebound education program for a period of not less than one year;
- 2. Suspended for a period of not less than one year; or
- 3. Expelled and not be readmitted within a one-year period, if ever.

The governing Board, in their sole discretion, may modify the one-year duration of such disciplinary action on a case-by-case basis.

For the purpose of this policy, we will use the following definitions from A.R.S. §13-105

Weapon means any of the following:

- 1. A firearm;
- A knife, other than a folding pocket knife that has a blade the length of not more than 2 ½ inches or that does not have a mechanism by which the blade can be locked in the open position (regardless of blade length);
- 3. A destructive device;
- 4. A dangerous instrument; and
- 5. A deadly weapon as defined by A.R.S. §13-105

Simulated weapon means an instrument displayed or represented as a weapon.

Firearm means any of the following:

- 1. Any loaded or unloaded gun that will, that is designed to, or that may readily be converted to expel a projectile by the action of an explosive;
- 2. The frame or receiver of any such firearm;
- 3. Any explosive, incendiary, poison gas, bomb, grenade, rocket having a propellant charge of more than four (4) ounces, missile having an explosive charge of more than one-fourth (1/4) ounce, mine or similar device; or
- 4. Any combination of parts that could be readily assembled to form a firearm

Destructive device means:

- 1. Any device other than a firearm that will, or is designed to, or may be readily converted to expel a projectile by any means of propulsion, such as a BB/pellet gun, slingshot, bow or crossbow; or
- 2. Any collection of parts that could be readily assembled to form a destructive device

Dangerous Instrument means anything other than a firearm, knife or destructive device that is carried or possessed by a student for the purpose of being used or being available for use to cause death or inflict serious physical injury.

School Premises means the school, school grounds, school transportation vehicles or any premises, grounds or vehicles for school purposes and includes bus stops and premises where school-sponsored events are held away from school property.
